Terms & Conditions for the Data Entry Operators.

Their engagement is further subject to following conditions:

- The contractual engagement will be for a period up to March 2025 and co-terminus with the program period.
- He/She will be paid a fixed monthly Pay of Rs.22000/-(Consolidated) (Rupees Twenty two thousand only).
- He/She will be required to function in coordination with Regional Nodal Officers, Principal, Teacher Coordinators at JNVs, Vigyan Jyoti Team at NVS Headquarter.
- He/She will maintain a record of all data and details of activities conducted in JNVs. He/She will also maintain a Region-wise record of the achievements of VJ scholars.
- He/She will not be entitled to Dearness Allowance, residential telephone, Transport facility, residential accommodation, medical reimbursement, etc. He/She will be entitled for reimbursement of expenses on official travel as per norms of DST.
- Samiti may terminate their services at any time by giving one month's notice. However, if he/she wishes to have pre-mature termination of their engagement, he/she may do so by giving one month's notice or one month's pay in lieu of notice.
- His/Her services are extendable at the discretion of the competent authority, subject to satisfactory performance or the continuation of the program as the case may be.
- He/She will be entitled to 08 days of leave in a calendar year on a pro-rata basis. No pay calculated on a pro-rata basis. The unavailed leave in a calendar year cannot be carried forward to the next calendar year nor any encashment of leave at credit is admissible.
- Income tax or any other tax as applicable shall be deducted at source at the prevailing rate before effecting the remuneration.
- As a full time DEO, he/she has to perform duties related to implementation of Vigyan Jyoti Program and any other duty assigned to him/her by the Vigyan Jyoti Team at NVS Hqrs.
