1. List of items to be sold will be approved by the Vidyalaya Verification Committee initially and will be displayed on the notice board along with MRP and discounted price on MRP.

2. No other items other than the approved items will be allowed to sell in tuck shop.

3. The employee of the JNV cannot participate in the tender process. The personal involvement of employee in this process is liable for disciplinary action as per NVS, Norms.

4. The eatable items to be sold should be branded & from the reputed firms.

5. Tuck shop should be kept opened as per the direction of the Principal, so as to be useful for the students ie. on Saturdays, Sundays & Holidays.

6. Owner will not be allowed to enter the campus on any other day for any reason except decided days. Also nobody will accompany him unnecessarily during the time of sale.

7. No separate permanent room facility will be given for Tuck shop the owner has to make his own arrangement keeping in mind safety & security of the goods to be sold.

8. Vidyalaya administration or the committee constituted by the Vidyalaya will have the authority for surprise checkup of items, its quality & selling price.

9. The Tuck shop owner should behave properly with the students, if any complaints are received from the students, the Vidyalaya authority reserve the right to cancel the tender without assigning any reason at any stage/time.
