Respected Sir,

With reference to the subject cited above it is aware that the scheme of establishment of Navodaya Vidyalayas in the country was launched in 1985-86 to provide good quality education to the talented children predominantly from rural areas. These are co-educational residential institutions aimed at serving the objective of academic excellence coupled with equity and social justice ,

As envisaged under the scheme one Jawahar Navodaya Vidyalay is to be established in each district of the country. As on date 598 JNVs are established except in Tamilnadu state. In case of Gujarat state JNVs in the 25 districts are established against the total no's of 33 districts in existence as on 31.05.14. As per Govt. Policy remaining districts are required to be covered among which Chota Udaipur district is one.

The minimum requirements for establishment of the Jawahar Navodaya Vidyalaya are

1. The pre-requisite for opening of the Navodaya Vidyalaya is provision of about 30 acres of suitable land, free of cost along with adequate temporary rent free accommodation sufficient enough to accommodate approx. 240 students, to be provided by the State Government to run the Vidyalaya for a period of 3 to 4 years or till the construction of its own permanent Vidyalaya Building Complex.
2. The site should be connected with proper road / rail and other communication links & transportation facilities.
3. The water source including ground water should be available for water supply provision.

4. Sufficient power supply with the provision for 100KV substation in the permanent campus of Vidyalaya as required in future.
5. In addition to the basic facilities, bank, post office and Government Hospital should be nearer to the proposed JNV site.
6. Since District Collector & Magistrate of the district is the Chairman of JNV, the permanent campus should be properly connected with the District Hqrs, so as to facilitate the children, parents and the officials to reach.

Keeping in view of all the above requirements, I would like to request you that I shall be grateful if you could kindly identify and provide suitable land for establishment of Jawahar Navodaa Vidyalaya, Chota Udaipur including its temporary site and help the deserving children of Chota Udaipur district getting the quality education provided by the Jawahar Navodaya Vidyalaya.

Respected Sir,

With reference to the subject cited above, it is to inform you that as per the directions of Hon'ble Deputy Commissioner, NVS, RO, Pune, undersigned has been directed to establish Jawahar Navodaya Vidyalaya in new District Chhota Udepur.

The minimum requirement for establishment of JNV are as follows.

1. Rent Free temporary building sufficient for 240 students for running the vidyalaya for minimum period of 3 to 4 years till shifting at permanent site.
2. 30 Acers of free of cost land to be transferred by state govt. to construct permanent complex of JNV. Now even 10 Acers of otherwise suitable land also be acceptable.
3. Site should be connected with proper road/railway & other communication skills.
4. Water sources including sufficient ground water should be available for water supply provisions.
5. Sufficient power supply with provision for establishing 100 KV substation in the campus of the JNV subsequently is required.
6. Facilities like Bank, Post Office & Govt. Hospitals closed to the site.
7. As District collector is the Chairman of the management of JNV, it should be properly and easily connected with Dist. Hqrs. so as to facilitate the children, parent and other official to reach vidyalaya.

Keeping in view of above requirements, you are kindly requested to identify Two - Three sites in the District Chhota Udepur and recommend the best site among alternatives for establishing J.N.V. in Chhota Udepur.
